In his [white collar defense](#) practice, Jonathan represents executives, municipalities, and public officials in criminal matters and investigations related to misappropriation of funds, public corruption, and violations of the Brown Act. In one of his most notable successes, he defended a real estate developer and its co-managing partner in a [10-month jury trial of a high-profile public corruption matter](#). *Daily Journal*, California's leading legal publication, awarded Jonathan and partner [Stephen G. Larson](#) its prestigious "[California Lawyer Attorneys of the Year \(CLAY\) Award](#)" for their efforts securing acquittals for Larson's clients. Jonathan then served as counsel for the real estate developer and its co-managing partner in [two civil rights suits](#) seeking damages for the retaliatory investigation, which resulted in a [\\$65 million settlement](#) in November 2020.

After honing his litigation practice at two Am Law 200 firms, Jonathan joined Larson when the firm was founded in 2016. During law school, Jonathan served as a judicial extern to the Honorable Virginia A. Phillips of the U.S. District Court for the Central District of California. Jonathan's Representative Matters

- Secured a [complete defense verdict](#) for the co-managing partner of a real estate developer, defeating allegations that three county officials took bribes from the co-managing partner in exchange for their approval for a \$102 million settlement of a land dispute.
- Following the complete defense verdict at trial, obtained a [\\$65 million settlement](#) for the real estate developer and its co-managing partner for the retaliatory investigation and malicious prosecution, among other civil rights claims.
- Obtained a [\\$10 million jury verdict and judgment](#) against the Rose Bowl Aquatics Center and in favor of a minor child abused at the defendant's facilities.
- Represented a municipality and its council members against allegations of illegal payments of public funds, obtaining dismissal through an anti-SLAPP motion which was upheld on appeal.
