A former U.S. ambassador and the 27th National Security Advisor, Robert O'Brien cofounded the firm with Stephen G. Larson and is partner emeritus at Larson. Robert is an accomplished litigator, a skilled neutral, and an experienced diplomat.

Recognized as one of the "Top 100 Lawyers in California" by *Daily Journal* and one of the "500 Leading Lawyers in America" by *Lawdragon*, Robert forged his career as lead trial and appellate counsel in high-profile matters.

In his commercial litigation practice, Robert handles class action, entertainment, intellectual property, environmental, business torts, and complex contractual matters in state and federal courts. He is regularly appointed as a mediator, arbitrator, and discovery referee, having served as the Special Master in several of the largest cases in the Central District of California, including *MGA v. Mattel* ("Barbie v. Bratz"), *United States v. Standard & Poors* and *In re Allergan Securities Litigation*. Prior to co-founding the firm in 2016, Robert was the California managing partner of a national Am Law 200 firm for nearly a decade and, earlier in his career, was an associate at Skadden, Arps, Slate, Meagher & Flom LLP.

In addition to his litigation and alternative dispute practices, Robert is one of the country's leading diplomats and advisors on national security issues. As National Security Advisor, he brought a renewed focus to defense and industrial base issues, orchestrated the historic Abraham Accords in the Middle East, brokered economic normalization between Serbia and Kosovo, and achieved increased cooperation with America's allies across the Indo-Pacific. Previously, Robert was the Special Presidential Envoy for Hostage Affairs (SPEHA) and held the personal rank of ambassador. As SPEHA, he coordinated the government's diplomatic engagements on overseas hostage-related matters and successfully negotiated the return of over 25 hostages and wrongfully detained Americans.

Robert was the U.S. Alternate Representative to the 60th session of the U.N. General Assembly and a member of the Cultural Property Advisory Committee. He was the founding co-chairman of the State Department's Public-Private Partnership for Justice Reform in Afghanistan, serving under Secretaries of State Condoleezza Rice and Hillary Rodham Clinton. Robert was a senior legal officer at the U.N. Security Council in Geneva, Switzerland, and a Major in the U.S. Army Reserve JAG Corps. He was a member of the International Republican Institute delegations that observed the presidential election in the Republic of Georgia in October 2013 and the parliamentary election in Ukraine in October 2014. Robert was also a Pacific Council on International

honor. In 2019, Robert received the Dr. Miriam and Sheldon Adelson Award for the
Defense of America and Israel. The U.C. Berkeley School of Law presented Robert with
the Stefan A. Riesenfeld Memorial Award for outstanding contributions to the field of
international law in 2011.

Robert is a Distinguished Senior Fellow at the Pepperdine School of Public Policy and a Carnegie Distinguished Fellow at the Columbia University Institute of Global Politics. He also serves as the Chairman of the Global Taiwan Institute (GTI) Task Force on US-Taiwan Relations, and he is a co-chair of the Center for Strategic and International Studies (CSIS) Commission on Hostage Taking and Wrongful Detention. In 2017, the Los Angeles Business Journal named Robert one of the 500 "Most Influential People" in Los Angeles.
